## NOMINATION FOR STALLIONS AT STUD RULES

The Riding Pony Stud Book Society Ltd (RPSBS) Stallion Return process and rules were changed effective as at June, 2016.

The Nomination Form for Stallions at Stud replaced the Stallion Return process and is effective from the 2015/16 breeding season.

All RPSBS Section A and Approved Stallions must be nominated using a Nomination Form for Stallions at Stud for the appropriate breeding season and pay the associated fee.

- 1. A \$30.00 nomination fee (non-refundable) for each stallion to be used at stud is applicable for each breeding season. A Nomination Form for Stallions at Stud must be completed and lodged with the National Office by 31 July each year.
- 2. Lodgement of the Nomination Form for Stallions at Stud after 31 July for the relevant breeding season, may attract a late fee.
- 3. Registration Applications received with a Certificate of Service where the stallion has not been approved for the breeding season applicable, will not be accepted, until the lodgement of the Nomination Form and applicable fee has been paid.
- 4. Certificates of Service books are available from the Society at a cost of \$55.00 each, including postage.
- 5. No Certificate of Service is required if the Stallion owner/lessee of the stallion at the time of service is the owner/lessee of the mare, at the time of foaling.
- 6. Certificates of Service where the stallion and/or mare details have been altered will not be accepted for the purpose of Registration.
- 7. No nomination fee is required for stallions 25 years of age or older however a Nomination Form for Stallions at Stud for the relevant breeding season must be lodged and a Certificate of Service issued as necessary to mare owners.
- 8. Artificial Insemination and/or use of frozen semen for service must be clearly detailed on the Certificate of Service.
- 9. Where frozen semen is used from a deceased stallion, a Nomination Form for Stallions at Stud must be lodged.
- 10. Nomination Forms for Stallions at Stud must be authorised by the Stallion owner, lessee and/or the authorised agent.
- 11. Agents must be authorised to operate on behalf of the Stallion Owner. Authorisation must be provided in writing by the Stallion owner and lodged with the National Office at the same time, detailing the start and finish dates applicable.
- 12. Section A Stallion owners/lessees/agents must be current financial members of the Society at the time of engaging the services and for the completion of any RPSBS paperwork thereafter. From 1 January 2021 Approved Stallion owners/lessees/agents are not required to be current financial members at the time of engaging the services and for the completion of any RPSBS paperwork thereafter unless they are also the current registered owner of a Section A stallion, colt, mare or filly, then membership rules apply. Prior to 1 January 2021 they required membership.
